Re: Notice of Ubicom Acquisition and U.S. Export Controls

Dear Distributor,

This letter is to inform you that Ubicom, Inc. ("Ubicom") entered into an Asset Purchase Agreement with Qualcomm Atheros, Inc. ("QCA") pursuant to which QCA acquired substantially all of the assets of Ubicom. In connection with the acquisition, Qualcomm Incorporated, QCA's parent company (collectively, "Qualcomm") and Ubicom conducted a due diligence investigation in the export practices of Ubicom. As part of the due diligence process, Ubicom discovered that it failed to obtain authorization from the Department of Commerce's Bureau of Industry and Security (BIS) for certain exports of Ubicom's products to certain of its customers and suppliers.

On February 14, 2012, Ubicom filed a voluntary self-disclosure to the U.S. Department of Commerce's Office of Export Enforcement (OEE) informing them of these potential violations. On behalf of Ubicom, Qualcomm filed Commodity Classification Requests with BIS requesting formal classifications for its multithreaded and network processors, related evaluation PCB hardware, software and technology. These requests are currently pending with BIS. In accordance with U.S. export control laws, many of these products are not eligible to be exported or transferred from distributor site, except as where Comments below state "Authorized to ship now."
