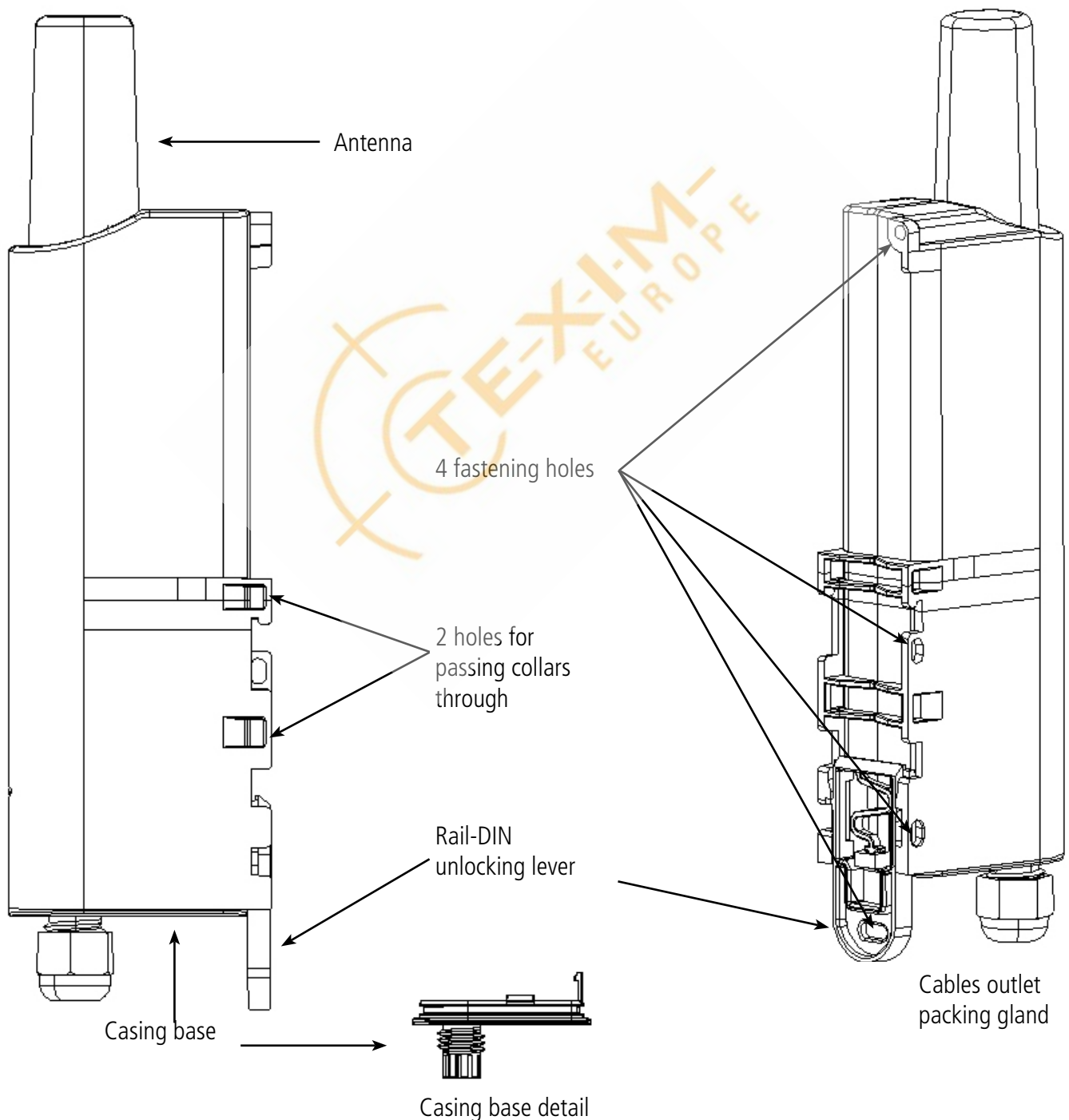
IMPORTANT NOTE: the Sigfox Repeater can be started or restarted using a magnet. **The Sigfox Repeater must be declared on the Sigfox network to be used.**

Description:

- The Sigfox Repeater is a ready to use radio transmitter allowing to expand sigfox network coverage
- This product meets the needs of users who require to connect any sigfox products in areas with few network coverage.
- Like other Sigfox devices the Sigfox Repeater has to be declared on the Sigfox back-end.
- The Sigfox Repeater is an uplink service message repetitions for devices, the repeater can not repeat downlink address to devices.
- It allows to define a list of products to be repeated (White List) that can be configured in different way.
- A facilitated implementation procedure is available.
- The Sigfox Repeater is powered by a replaceable internal battery.

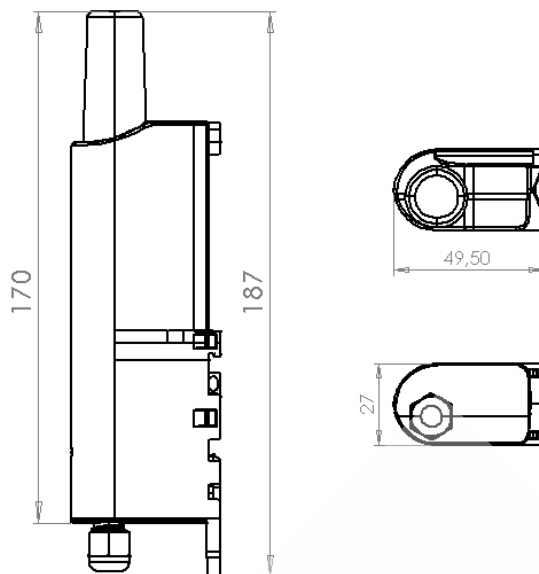

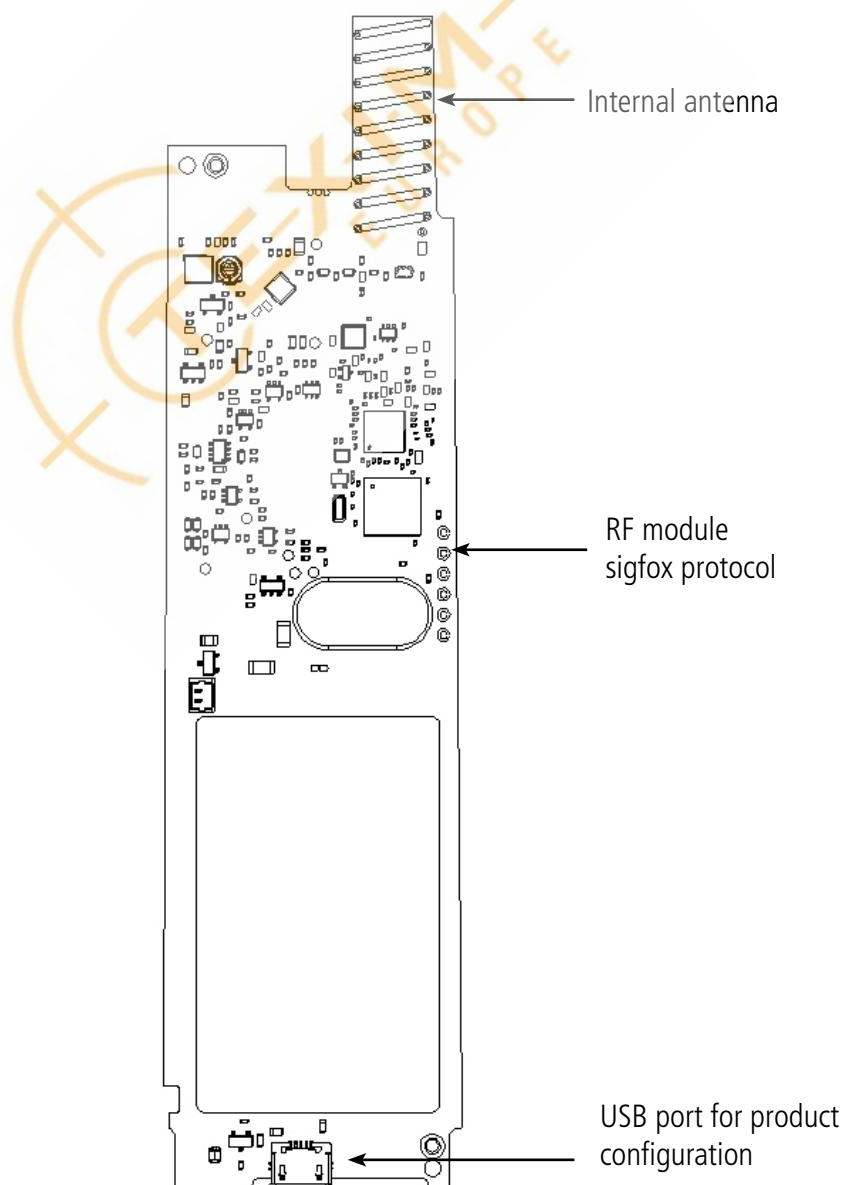

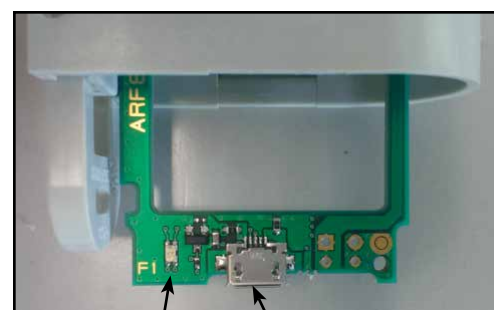
1.5. User interface

The repeater has two elements that serve as an user interface : a LED and an USB port

1.5.1 USB Port

The USB port is a micro-usb (similar to what is used in most of today's smartphones). It is solely used for device configuration and has no other purpose. See section « 5. DEVICE CONFIGURATION ».

IMPORTANT NOTE: When the USB is plugged in, the device is still powered by the battery pack. Since the USB connection draws a non-negligible amount of power, make sure that you disconnect the USB cable once the configuration is finished (do not leave it on your desk with the USB plugged in)

USB port for product configuration

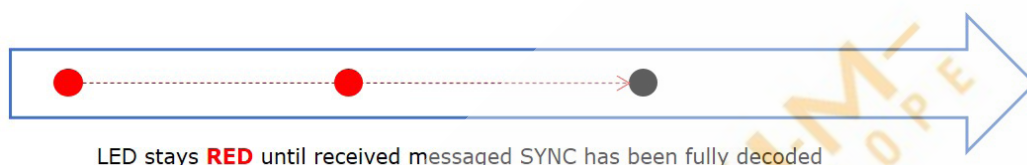
1.5.2 LED

The LED is used at many different stages of the product's operating life. The following table describes the LED behavior in those different cases. More details are provided in section 3.

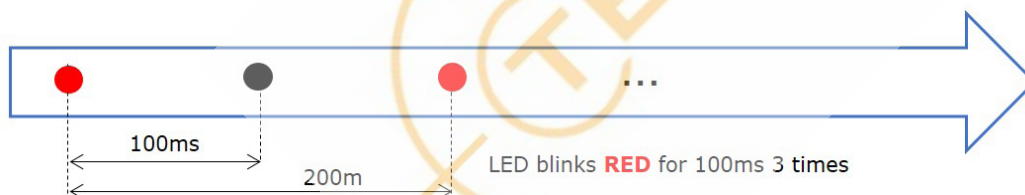

The LED can be used to monitor the repeater's state of operation :

1.5.2.01 SIGFOX message is detected



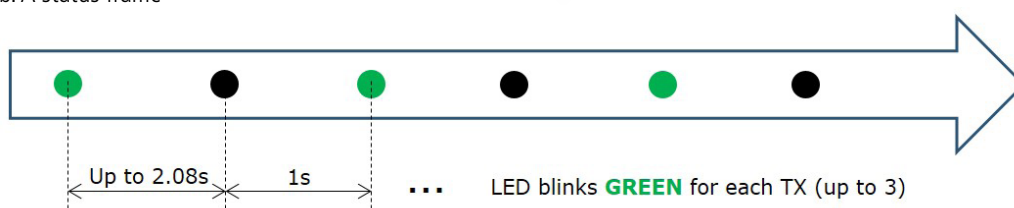

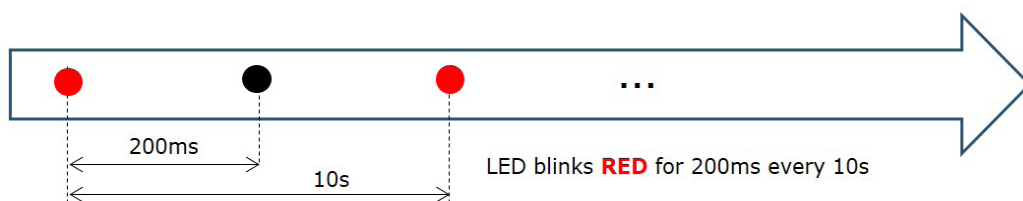

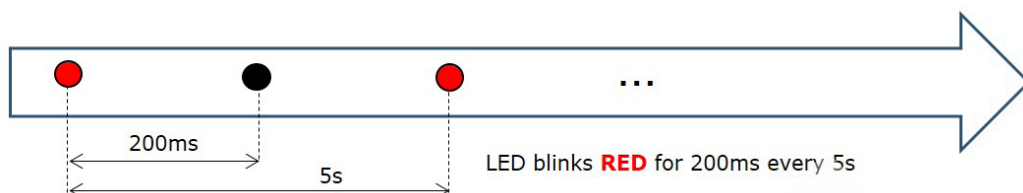

1.5.2.01 DEAD : the battery is dead. The repeater stops all activity except warning LED



1.6. Mobile application

A mobile application is available on the Google store, named «adeunis sigfox Repeater App», and for Windows on our website. This application allows you to configure a repeater but also to manage its environment and the topology.

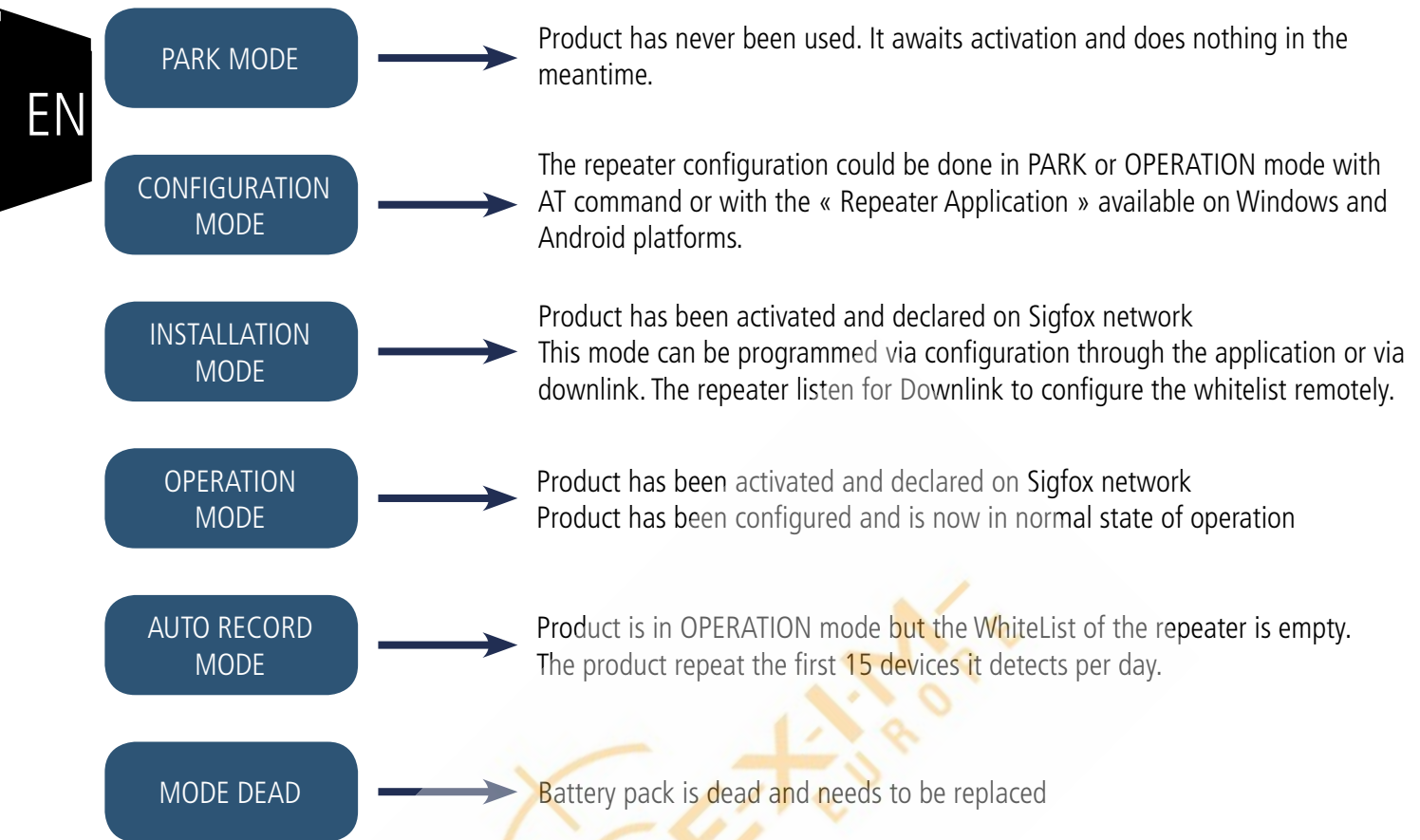

IMPORTANT NOTE: the mobile application need the OTG feature on your smartphone, please check by downloading a dedicated app like « USB OTG Checker » for example.

2. ACTIVATION PROCESS AND CONFIGURATION

The product has 6 states of operation:



2.1. Configure the White List

The White List of the repeater can be configured in 3 different ways.

- «Auto-record» mode



When activated, if the White List of the repeater is empty, the repeater will enter in OPERATION mode with Auto-record and repeat automatically the first 15 devices detected. A reset of this list of IDs is made every time the Status frame is sent to the sigfox back-end (24h by default, linked to the S300 register). It is possible to freeze this list of repeated device to make it permanent with a downlink (see downlink section). Be careful, in this mode the product can repeat sigfox devices that you don't know and if you freeze the list it will freeze the unknown devices as well.

PAY ATTENTION : this mode is not recommended in noisy environment.



- Via USB

Configure the White List thanks to the repeater application or using AT commands. Refer to the dedicated section (2.3.1.03)

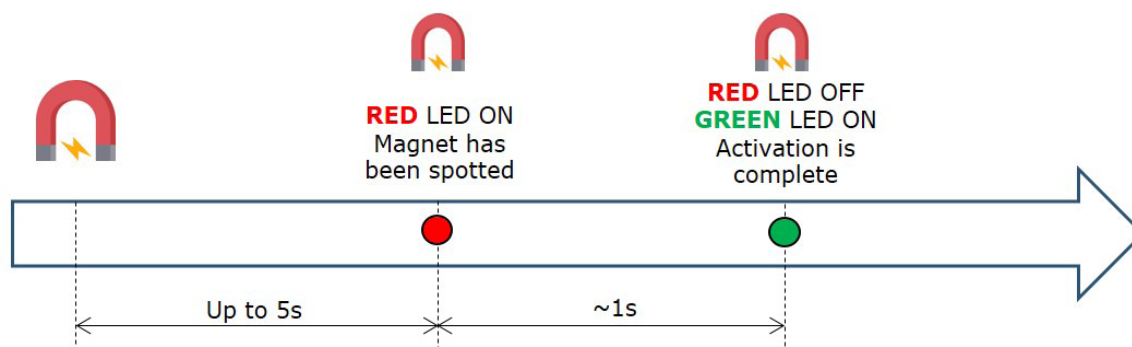
- Via Downlink



The repeater can be switched into INSTALLATION mode via a downlink. In this mode the repeater will stop to repeat device and will listen for downlink containing the ID of the device to be added to the White List. In OPERATION mode, every day (frequency linked to the status frame - S300 register) the repeater opens a listening phase to receive a downlink to add or remove ID from the White List. Refer to the dedicated section (3.0 Operation mode)

2.2. Activating the repeater

By default the repeater is in PARK mode. In order to be used, it needs to be declared on the sigfox back-end and then activated. For this, a magnet is needed. The following sequence has to be followed:



NOTE: the magnet must be maintained until the GREEN LED lights up. Otherwise, start again. The magnet zone is shown on paragraph « 6.3 Starting up the product using a magnet ».

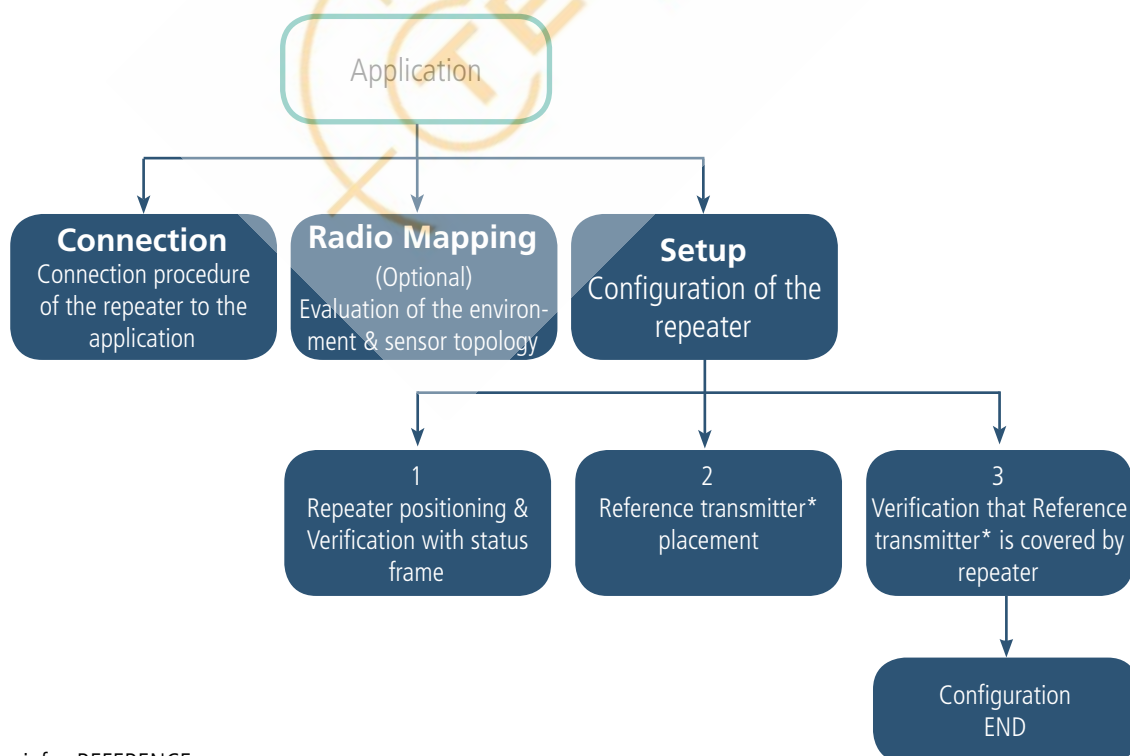
Once the product has been activated, it switches to operation mode.

2.3. Configuration mode

The repeater configuration could be done in PARK or OPERATION mode with the « Repeater Application » available on Windows and Android platforms or with AT command.

2.3.1 Configuration through the Repeater Application

The Repeater Application follows the below flowchart:

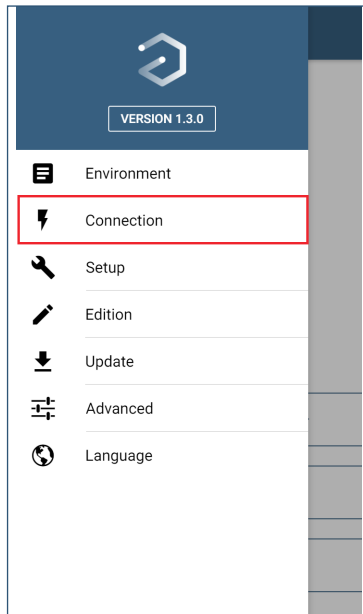


*The adeunis sigfox REFERENCE TRANSMITTER (ARF8260) is a device tool to help install the repeater (see product user guide for more information).

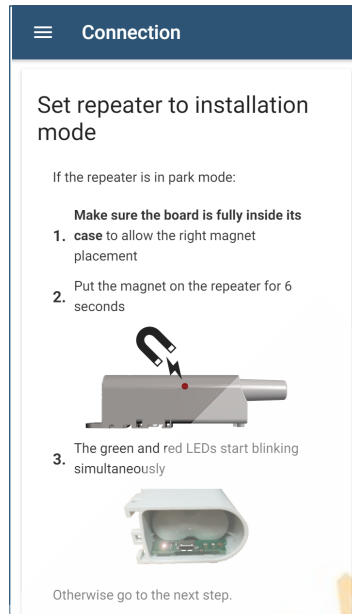
2.3.1.01 Connection

This first step shows you how to connect your repeater to your tablet, phone, etc.

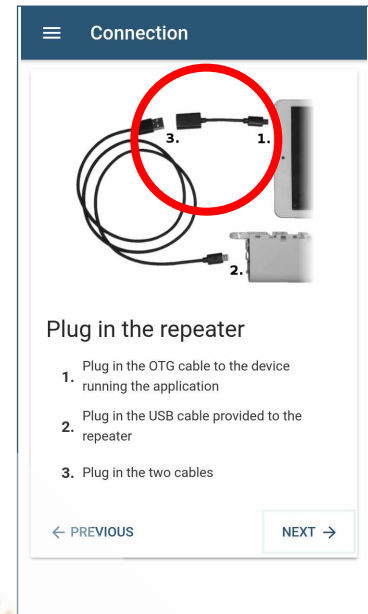
- Android devices : you need an OTG cable to connect to your tablet/phone
- Windows devices : you need a driver available on adeunis' website



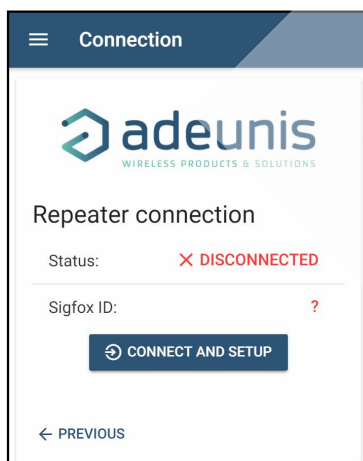
1. Click on «Connection»



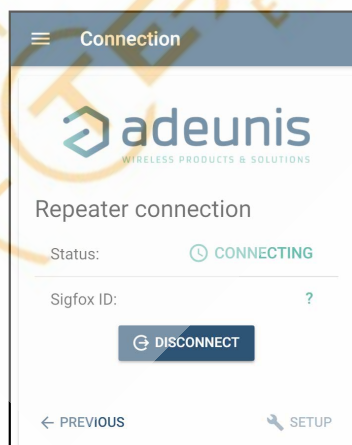
2. See section 2.1



3 . Connect the device
PAY ATTENTION to the cables: if reversed, the connection won't work.



4. Click « Connect »



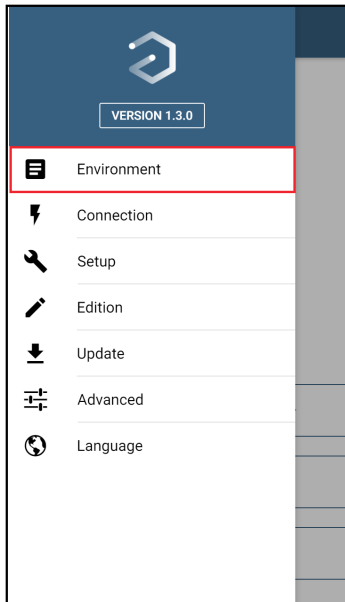
5. Once connected,
 the repeater ID is displayed

Once your device is properly connected, you can either go to the « Radio Mapping » section (optional) or the « Setup » section.

2.3.1.02 Radio mapping (Optional)

The « Radio Mapping » section helps you to determine how many repeaters you'll have to deploy for a given sensor topology.

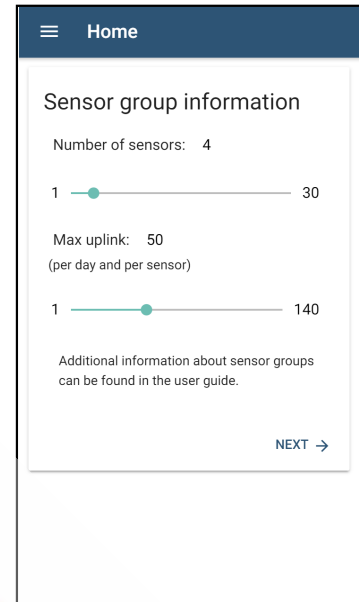
It gives a general overview but the result cannot be taken « as is » : field experimentation is mandatory to ensure proper coverage of all devices.



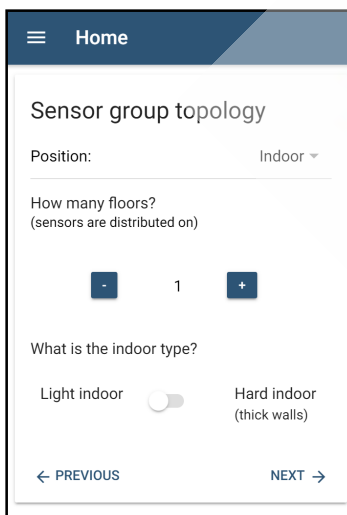
1. Click on « Environment »



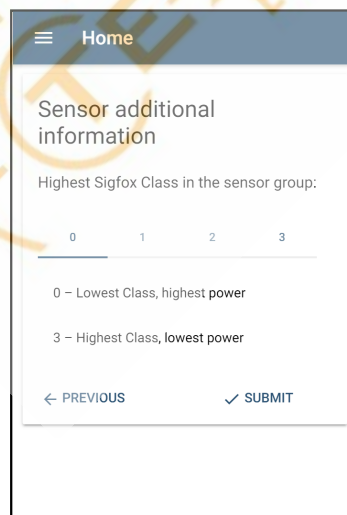
2. Click on «Start Radio Mapping»



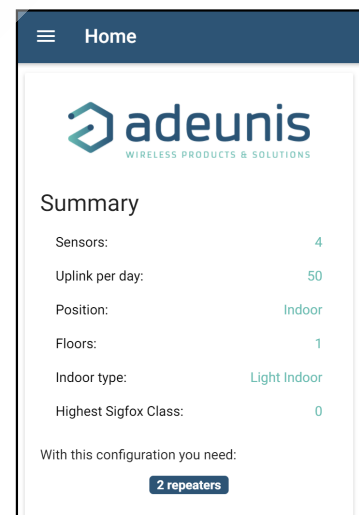
3. Indicate the number of sensors to be repeated and their uplink traffic volume



4. Sensor group topology asks in which environment the sensors are deployed



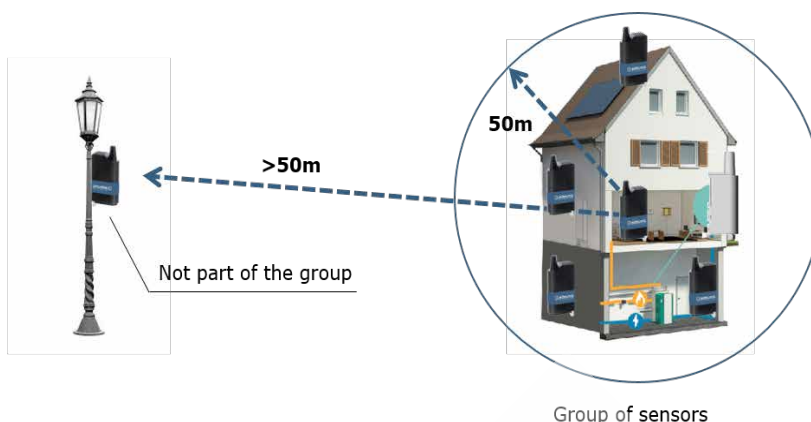
5. Additional information asks for the sensor's SIGFOX class

Definition of a group

Depending on the site, the sensors can be scattered in different ways. It is impossible to cover all cases in the application, hence the notion of group was introduced. An group of sensors can be defined as any number of sensors contained within a bubble of 50m radius:



Topologies description

Different types of environment are identified:

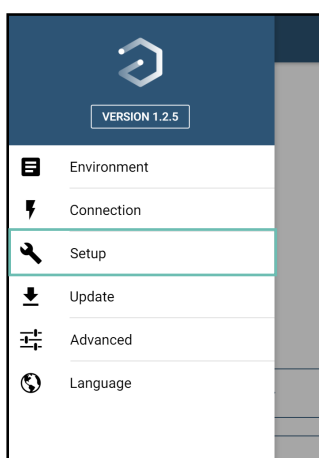
Type	Description
Outdoor	The device is placed in an open area, without specific obstruction
Light indoor	The device is placed indoor, in a not-too-harsh environment: near windows, outer walls, open-space type environment, floors where rooms are separated by light partitions
Hard indoor	The device is placed indoor, in an environment that contains heavy concrete / metal walls
Deep indoor	The device is placed in underground-type environments (cellar, basement, etc.)
Mixed	Mix of either of the above

2.3.1.03 Setup

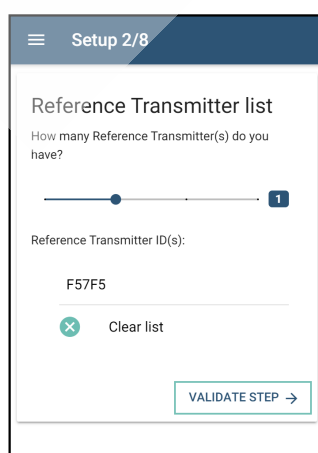
The setup section guides the user through the process of installation & configuration of the repeater.

The Sigfox Repeater has to be connected before going through this phase (see section 2.2.1.01).

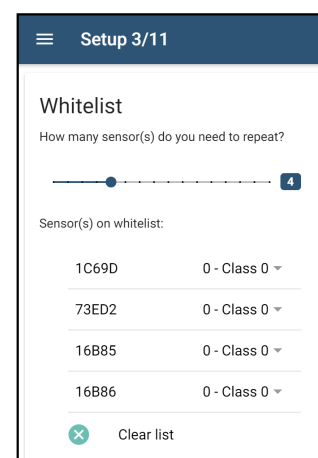
• Step 1: White List configuration



1. Click on « Setup »

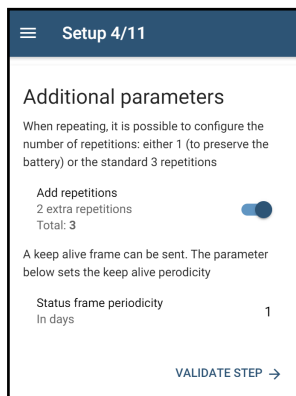


2. Enter the IDs of the Reference Transmitter you have in your possession



3. In order to be repeated, the sensors IDs have to be entered in a WHITELIST. IDs that are not in the Whitelist will not be repeated

• Step 2 : last elements of configuration

Additional parameters

When repeating, it is possible to configure the number of repetitions: either 1 (to preserve the battery) or the standard 3 repetitions

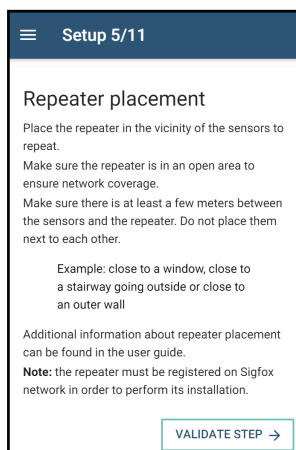
VALIDATE STEP →

Before finishing the configuration, a few other elements need to be checked :

- The number of repetitions. A classic SIGFOX device uses 3 « repetitions » when transmitting : the first transmission + 2 repetitions. The repeater allows to choose to only do the first transmission if we want to preserve the battery. This configuration is at your own risk : use it only if radio conditions are good.
- The keep-alive message periodicity. By default, the repeater sends a keep-alive message every 24h. this periodicity can be changed.

• Step 3 : Repeater positioning

Repeater placement

Place the repeater in the vicinity of the sensors to repeat.

Make sure the repeater is in an open area to ensure network coverage.

Make sure there is at least a few meters between the sensors and the repeater. Do not place them next to each other.

Example: close to a window, close to a stairway going outside or close to an outer wall

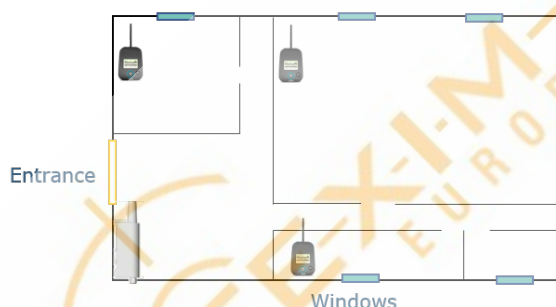
Additional information about repeater placement can be found in the user guide.

Note: the repeater must be registered on Sigfox network in order to perform its installation.

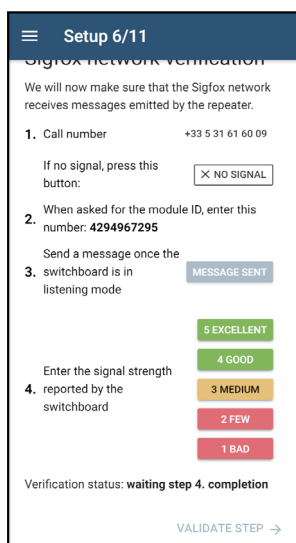
VALIDATE STEP →

During this step, try to position the repeater in the environment and check that it is seen by the SIGFOX network.

The repeater should be placed intelligently: at approx. equal distance from all sensors, while simultaneously near opened areas to make sure it reaches the SIGFOX network.
For example:



Once the repeater placed, check that the choice is good by verifying if the repeater is covered by the SIGFOX network. For this, use the online server that SIGFOX has set up for such purposes, or check on your sigfox backend account the quality of the radio link of the repeater frames :

Sigfox network verification

We will now make sure that the Sigfox network receives messages emitted by the repeater.

1. Call number +33 5 31 61 60 09

If no signal, press this button: **X NO SIGNAL**

2. When asked for the module ID, enter this number: **4294967295**

Send a message once the switchboard is in listening mode **MESSAGE SENT**

Enter the signal strength reported by the switchboard

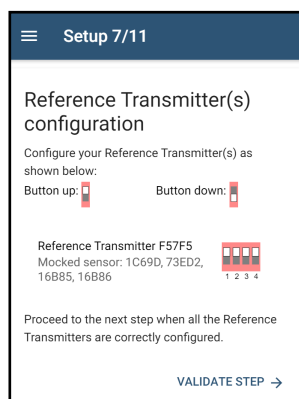

The application will tell if the chosen location is satisfactory or not.

• Step 4 : Positioning of the Reference Transmitter

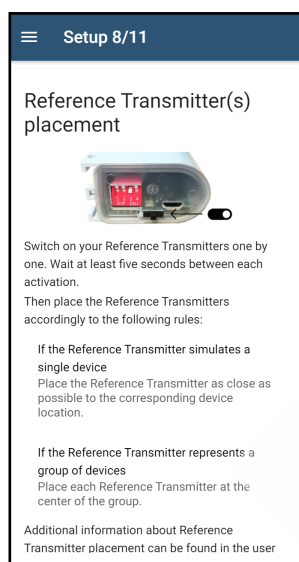


Once the repeater well placed and seen by the SIGFOX network, the next logical step would be to check that it sees the devices that have to be repeated. This step can be problematic because most of SIGFOX products out there are devices that transmit very few information per day : two messages per day, for example, is a common scenario.

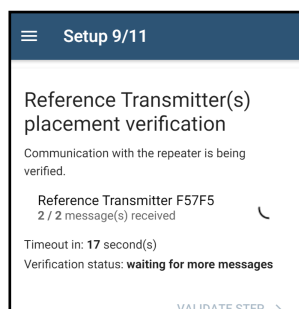
In those cases it will be difficult to check that the devices are properly repeated. So, the « Reference Transmitter » helps to solve these problems. The Reference Transmitter can be configured to send frames every 10 seconds or 1minute and for any SIGFOX Class.

The table below gives the different SIGFOX classes that exist for RC1 zone:

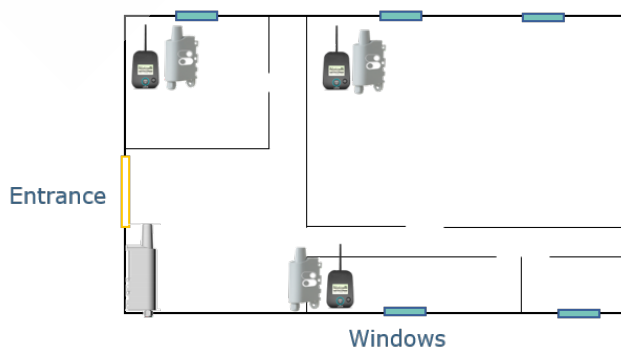
RC1 SIGFOX Class	Associated EIRP (Equivalent Isotropic Radiated Power)
0	$EIRP \geq 12\text{dBm}$
1	$12\text{dBm} \geq EIRP > 7\text{dBm}$
2	$7\text{dBm} \geq EIRP > 2\text{dBm}$
3	$EIRP < 2\text{dBm}$



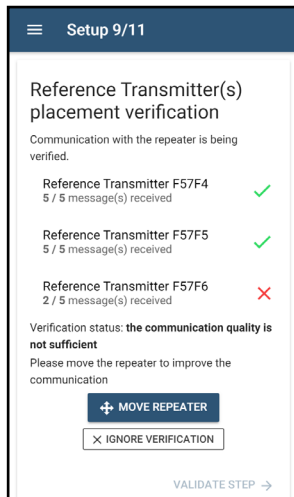
The Reference Transmitter is configured through a switch array (see Reference Transmitter documentation). The Application shows a picture of how to configure the switches.



Since the Reference Transmitter emulates a real sensor, it should be placed as close as possible to the actual sensor you need to repeat. This is important because the environment can have an important impact on radio waves propagation :

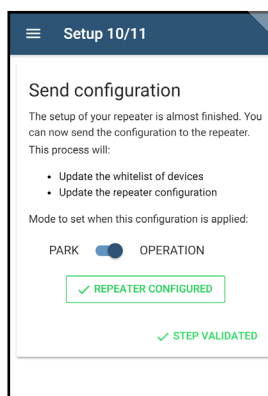
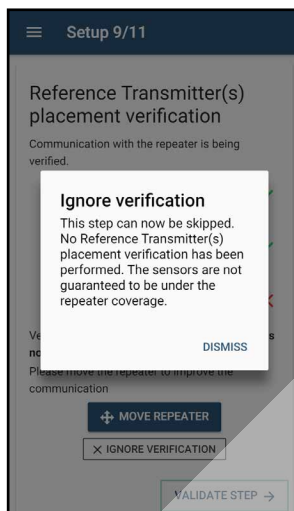


The remaining time for Reference transmitter placement test, as well as number of messages are provided since 1.3.0 application version . The Reference Transmitters will send messages to the repeater and the application will check the number of received messages. If a sufficient amount of messages is received within the allowed timeframe, the application will consider the device properly covered by the repeater and proceed to the next step.



If the reference transmitter placement verification failed, the repeater (or the sensor/reference transmitter) should be moved to improve connectivity between the repeater and the reference transmitter.

However, in some cases (for instance in cases of very noisy environment while testing), this verification should be ignored.



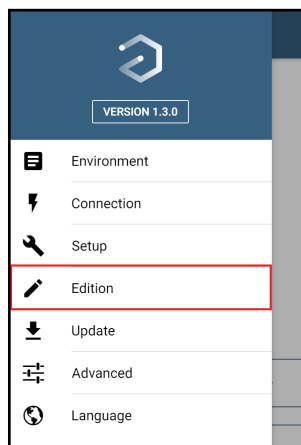
• Step 5: device configuration

The application now loads the configuration in the repeater.

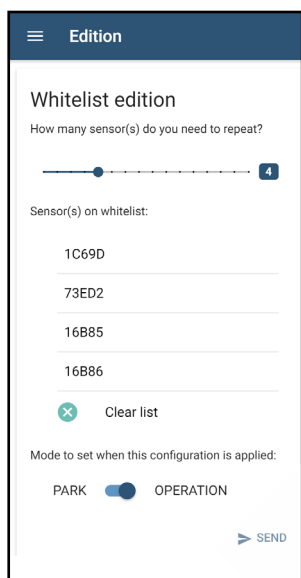
Note that you can put your device in PARK mode at this step.

The configuration is now completed and the repeater switches to operation mode.

2.3.1.04 White list edition

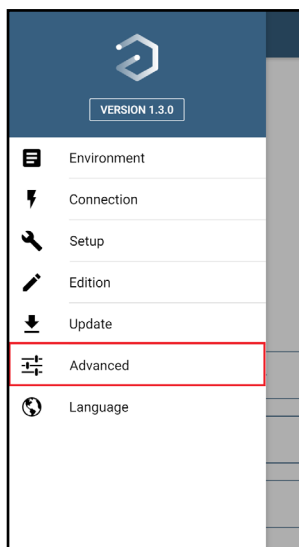


White list edition can be done over one single tab accessible over “Edition” menu.
White List edition is recommended only once a full configuration of the repeater has been already performed previously.

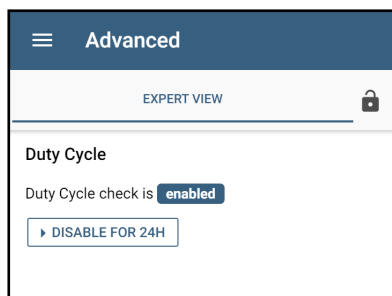


White list can be edited or cleared. In addition, the repeater can be also switched to PARK mode after this set-up change.

2.3.1.05 Advanced - Expert view: Duty Cycle check disable/re-enable

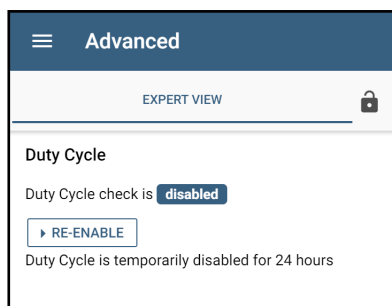


Duty cycle check can be disabled temporarily for 24hours or definitely disabled over Advanced menu.



To disable duty cycle check, just click on DISABLE FOR 24H or DISABLE.

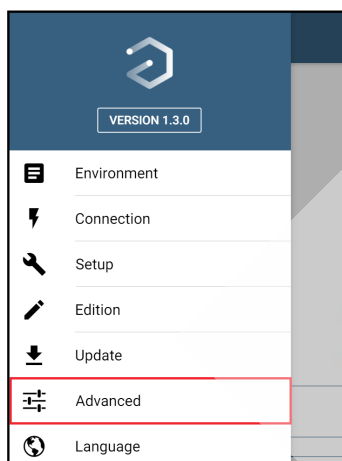
To disable the duty cycle the repeater should NOT be in PARK mode or set back in PARK mode. Indeed, in those cases, duty cycle check will not be disabled.



Duty cycle is re-enabled:

- Automatically after 24H (if the "Disable 24h" has been chosen)
- Or when the user re-enabled it via DL or via configuration through the application

2.3.1.06 Advanced - Expert view: Statistics access

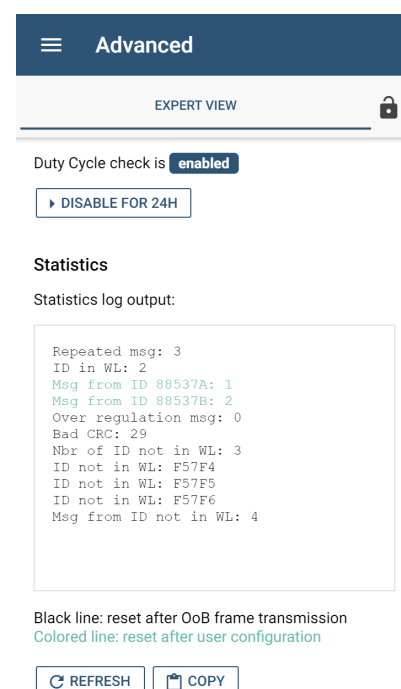


Repeater statistics are visible over Advanced menu.

Out of regulation represents the number of messages that are not repeated because of the duty cycle (36s of transmission per hour). If this number is regularly not null, it is advisable to reduce the repeater White List and install an additional repeater.

Device not in list represents the number of messages received from devices that are not in the White List. This number is to correlate with the previous graph. If this number has increased and at the same time the number of repeated messages has decreased, one solution may be to reposition the repeater so that it is further away from the disruptive devices and closer to the devices that it must repeat.

Bad CRC: Represents the number of Sigfox messages received with errors. Too many means that there are risks of losing messages to repeat because of a disrupted radio environment. This interference can come from collisions with other sigfox messages (see the previous case), or the presence of an interfering signal near the repeater. If this number has increased and at the same time the number of repeated messages has decreased, it will be necessary to take away the interfering signal source from the repeater (or vice versa)



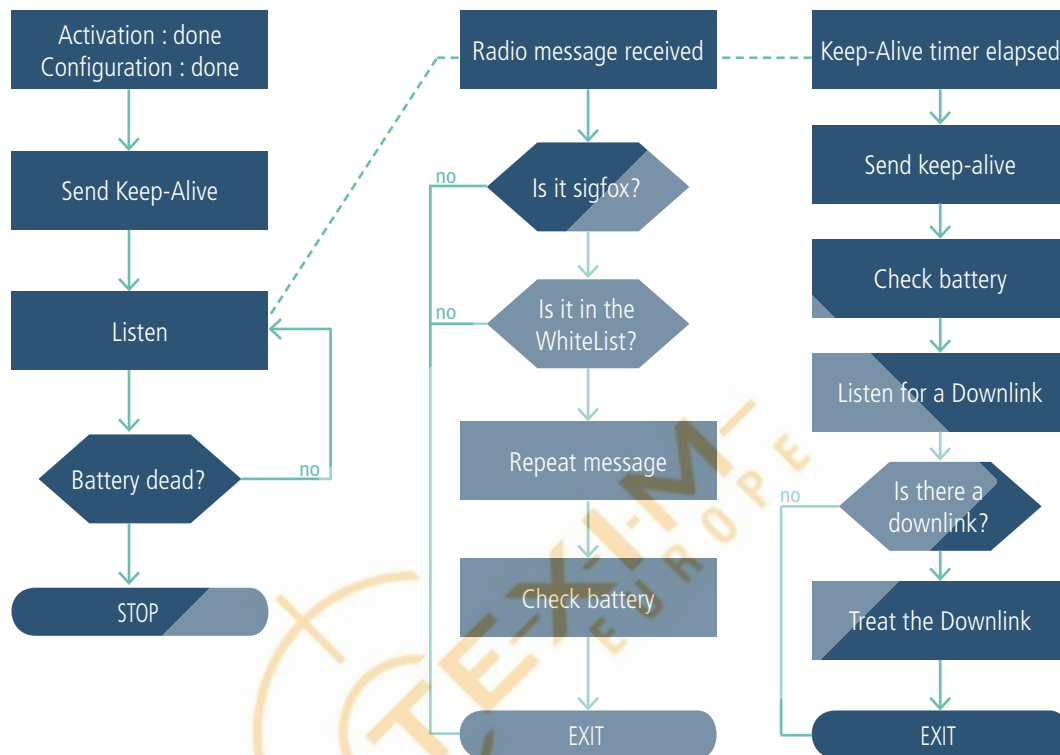
2.4. Operation mode

OPERATION mode is the normal mode of operation: the repeater is configured and functional and listens to any upcoming transmission.

There are 2 ways to enter OPERATION Mode from PARK Mode

1. Go through the configuration process using the application (See section 2)
2. Plug & unplug the USB : this will automatically put the repeater in OPERATION mode

OPERATION Mode executes the following (simplified) flowchart:



2.5. Installation mode

This mode allows to **configure the White List of the repeater remotely thanks to Downlinks**. In this mode, the repeater stops to listen messages from devices and opens "listening phases" to receive one or several Downlinks with the ID of the product(s).

This mode can be activated with a Downlink "Installation mode" or with a Downlink "Change register configuration" choosing S306=1 (see "description register section").

The White List can be completed within 4 days (for 15 IDs), thanks to the 4 daily downlinks included in the sigfox largest connectivity plan.



Return into OPERATION MODE, if:

- 4 UL are sent and no downlink received
- 4 DL are received with error (see DL error code in "downlink section")
- reception of a "WL confirmation" downlink (see "downlink section")
- White List is full (15 IDs provided)

In any case, the repeater will send a "WL confirmation". If IDs are in the White List the repeater will send the number of IDs contained in the WL and turn to operation mode and repeat the message from the device concerned, if the White List is empty, the repeater will send 0 and turn into "auto-record" mode.

2.6. Repeater monitoring with the sigfox backend

When receiving the messages from a repeated sigfox device, you should get the following result on the sigfox backend:

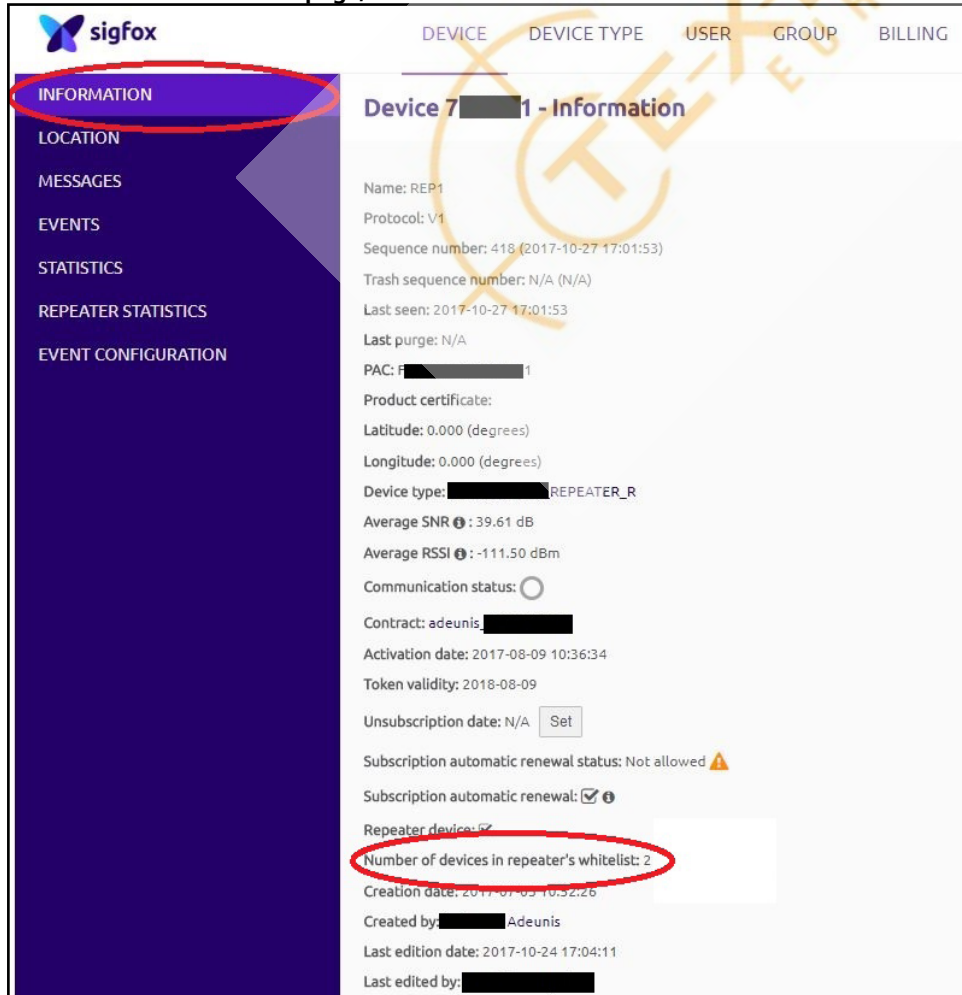
The repeated messages are identified by a percentage (red squares on the previous picture). For any given message sent by a sigfox device, the percentage represents the portion of repetitions coming from the repeater.

Repeater monitoring:

To benefit from repeater monitoring, **the adeunis sigfox Repeater must be visible from the Sigfox Cloud, so you have to declare it on the backend.** The simplest is to associate it with the contract of the objects which it must repeat. Repeater frames are free. To facilitate maintenance, it is advisable to enter the location of the repeater. Monitoring can be visual or programmed via the callback service repeater.



For monitoring information, the user can also consult the pages relating to his repeater:

- On **INFORMATION** page, the user can check the number of devices in the White List

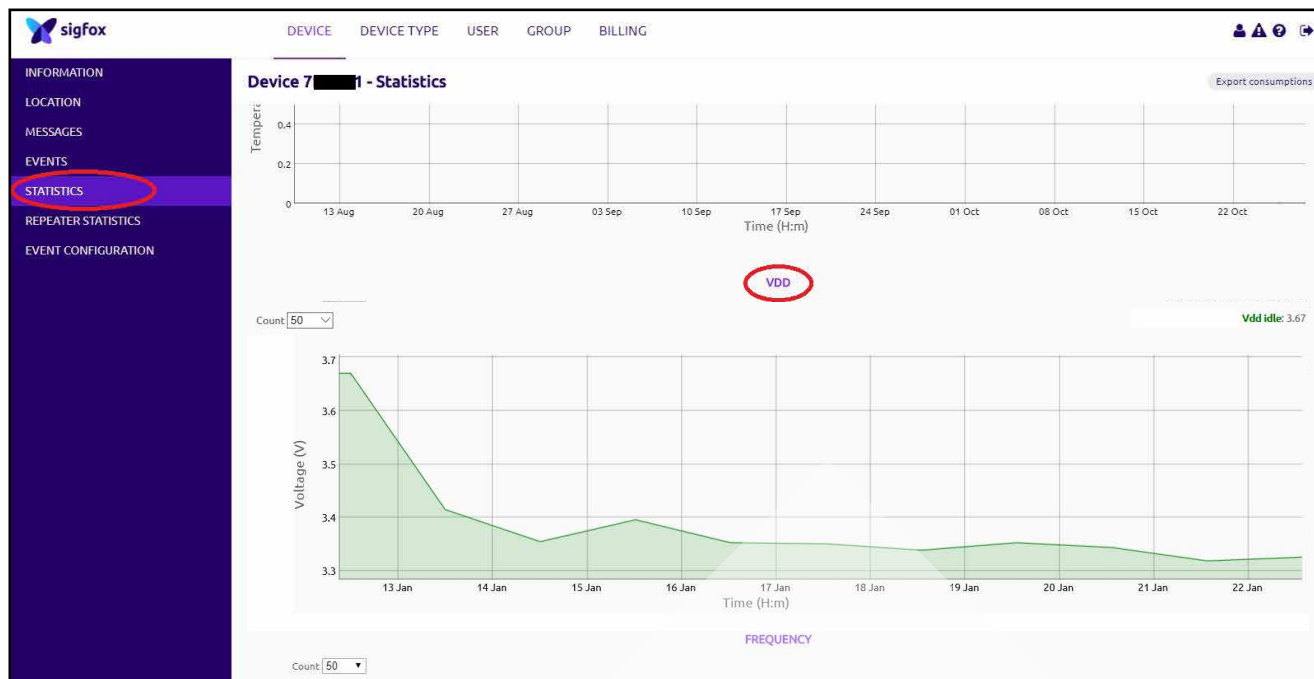

- On the **STATISTICS** page, the user can know the status of the battery (VDD graph)



The low battery threshold has to be set to 2700 mV.

- On the **REPEATER STATISTICS** page of the repeater, the user can consult indicators on the radio environment of the repeater:
 - The **MESSAGES-REPEATED** graph indicates the number of repeated messages between two status frames (default 24 hours). If the number of repeated messages decreases abnormally, it may be a failure of the device(s) to be repeated, or a change in the radio environment of the repeater. The following graphs help refine the diagnosis:



- The **DEVICES-NOT_IN_LIST** graph represents the number of devices that are not in the White List and that are received by the repeater between 2 status frames. Too many numbers can cause collisions between the frames of these devices and the frames to be repeated.



- The **MESSAGES_NOT_REPEATED** graph represents the number of unrepeated messages between two status frames (by default on 24h):

- Out of regulation represents the number of messages that are not repeated because of the duty cycle (36s of transmission per hour). If this number is regularly not null, it is advisable to reduce the repeater White List and install an additional repeater.
- Device not in list represents the number of messages received from devices that are not in the White List. This number is to correlate with the previous graph. If this number has increased and at the same time the number of repeated messages has decreased, one solution may be to reposition the repeater so that it is further away from the disruptive devices and closer to the devices that it must repeat.
- Bad CRC: Represents the number of Sigfox messages received with errors. Too many means that there are risks of losing messages to repeat because of a disrupted radio environment. This interference can come from collisions with other sigfox messages (see the previous case), or the presence of an interfering signal near the repeater. If this number has increased and at the same time the number of repeated messages has decreased, it will be necessary to take away the interfering signal source from the repeater (or vice versa)



The user can also define a SERVICE REPEATER callback in the device type of the repeater to, for example, analyze trends on the different monitoring data and trigger alerts on exceeding thresholds.

This SERVICE REPEATER callback will be activated at each status frame according to the periodicity defined during the configuration of the repeater. The available monitoring variables are as follows:

- Batt (float): the voltage of the battery (in Volt – Float value with two maximum fraction digits)
- White ListDevices (int): the number of devices in the White List. If 0, all messages are repeated
- RepeatedMsg (int): the number of repeated messages since the last status frame transmission
- UnwantedDevices (int): the number of unique devices not in the White List received since the last status frame transmission. If 15, means that the number is >14

- **UnwantedMsg (int):** the range of sum of number of messages received from all devices not in the White List: not repeated messages since the last status frame transmission:

3. DEVICE CONFIGURATION WITH AT COMMANDS

If you do not want to use the application, it is also possible to configure the device through a terminal and classic AT commands (**not recommended**).

Indeed, the Sigfox Repeater can be configured using the USB connector.

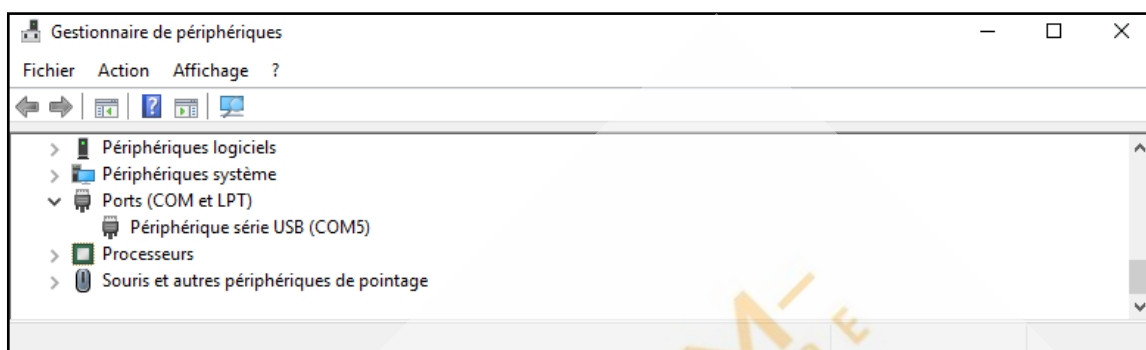
This connection allows you to communicate with the device via a virtual com port and to transmit AT commands in order to modify the parameters of the device.

WARNING : the USB connection does not supply power to the product, it induces a consumption of the product as long as the one is connected. It is therefore important not to leave the product connected too long.

3.1. Connecting the device to a computer

Connect the product to the USB input of a computer. The product has a Type B micro USB connector.

During connection, the device must be recognized by the computer as a Virtual Com Port (VCP) device.



Using Windows: Verification that the device has been recognized to be functioning properly can be obtained by consulting the device manager. You should see the USB series device with a corresponding COM port number appear during connection.

If you are not able to see a device of this type, you must install the USB driver for this device, available to download from our website: <https://www.adeunis.com/en/produit/repeteur-2/>

Select:

- DRIVER - stsw-stm32102_vcpdriver

3.2. Command mode

Use a COM port terminal in order to communicate with the device. We use the HERCULES COM port soft terminal available to download for free by clicking on the following link: https://www.hw-group.com/products/hercules/index_en.html

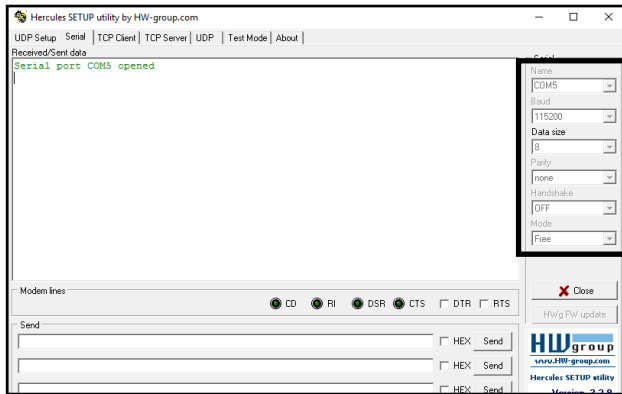
With Hercules, select the "Serial" tab, then configure the serial port with the following serial parameters:

- Select the serial port on which the device has been created with Windows (Name).
- Click on the "Open" button to open the serial port.

NOTE INFORMATION: If the com port has been opened correctly, Hercules will display the message "Serial COM3 port opened".

Alternatively, "Serial port com opening error" will be displayed, meaning either that the com port is already open for another application, or it does not exist.

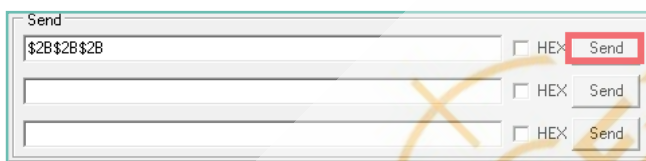


You must send a specific frame in order to move the device to configuration mode.
 Frame expressed in hexadecimals: 0x2B 0x2B 0x2B ou « +++ ».

For Hercules, this frame must be entered in one of the 3 lines available at the bottom. The hexadecimal format must be expressed using a "\$" in this program, which gives us the following frame: \$2B\$2B\$2B



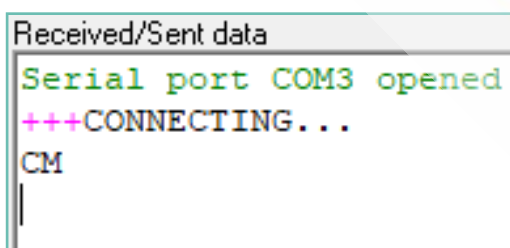
Send the transition frame in command mode in order to switch the device to configuration mode by clicking on the SEND button.



After a few seconds, You must see the 2 LEDs light up permanently.

On the com port terminal, you should also have «CONNECTING...» et « CM » feedback for Command Mode.

Sending a character on Hercules is displayed in magenta and receiving a character is displayed in black. If you do not see sending characters, this is probably because ECHO is not active on this program. To activate the option in the accessible menu, right click in the viewing window.



3.3. Configuration through a terminal and AT Commands

A command starts with 2 ASCII characters: "AT", followed by one or more characters and data (see the list below for the syntax of AT commands available on the modem).

Each command must finish with a "CR" or "CR" "LF" – both are acceptable.

(CR indicates: Carriage Return, LF indicates: Line Feed)

Once the command has been received, the modem will feedback:

<cr><lf> "Data" for ATS type playback control <n> ?, AT/S or AT/V

"O" <cr><lf>, for any other command when this has been accepted.

"E" <cr><lf>, if it refuses the command due to a syntax error, unknown command, unknown range, invalid parameter, etc.

"CM" <cr><lf>, if it accepts the input in command mode

Interpreting the previous example: the user wanted to modify the the transmission period of the Status Frame. The register S300 was verified and the parameters were saved before exiting. When exiting command mode, the device will start a new cycle of emission.

3.4. Description of the registers

ON switching on the product works according to the last saved configuration (Factory Configuration if it is the first start, or if this configuration has not been changed).

Commands such as Modification TTY<n>=<M> allow you to change the content of the registers: <n> representing the number of the register and <m> the value to be assigned. This latter is either a decimal value or a hexadecimal value consistent with the «encoding» column of the tables below.

Examples :

- ATS300=6 assigns the decimal value 6 in register 300
- ATS303=2 assigns the hexadecimal value 0x02 in register 302

It is imperative to save the parameters with the command AT&W before exiting the Command mode otherwise all changes will be lost.

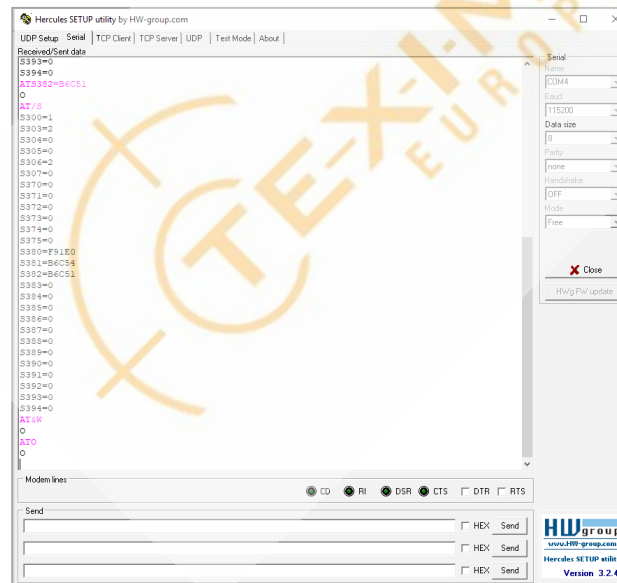
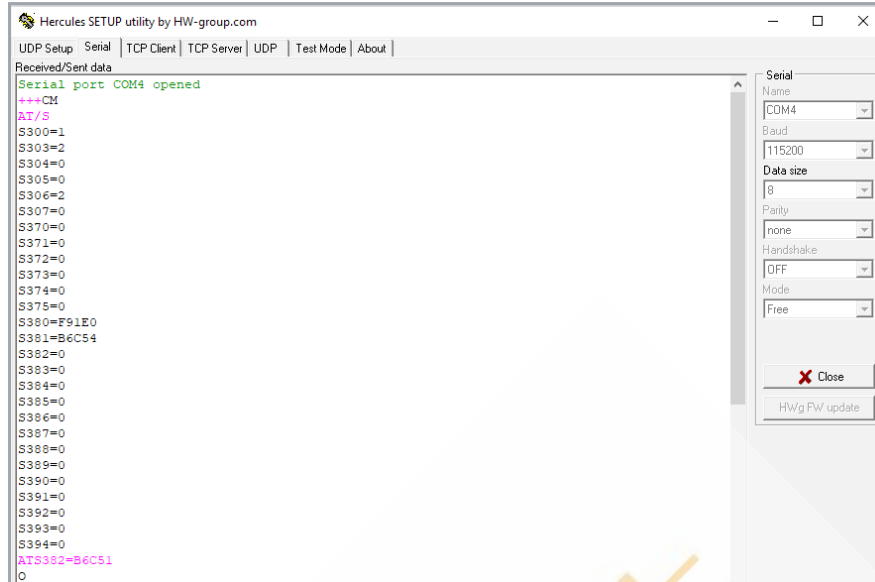

For example in the screenshot below we can see how to update your White List :

- Enter in Command mode (+++)
- Display registers list (AT/S) – this is optional still useful to check how many Sigfox devices (and which ones) you declared previously in this repeater
- Add an ID Sigfox at the 3rd place of white (ATS382=B6C51)
- Following command (AT/S AT&W ATO) just verify and save the changes done above.



IMPORTANT NOTE : If the White List is blank (all registers to 0), the repeater will repeat the 15 first sigfox devices it sees. This means that the White List (register 380 to 394) is automatically completed by the Sigfox Repeater.

The Sigfox Repeater uses this list of ID until the next transmission of its Status Frame (with the period given by register 300) and after transmission the list is again emptied (and the previous steps are repeated...).

WARNING : Using an empty White List is at your own risk : repeating any device means more power consumption (reduced battery life) and potential break of the Duty Cycle limit. In that case the repeater will automatically limit itself and discard upcoming messages.

4. DESCRIPTION OF THE REPEATER FRAMES

4.1. Uplink frame

All of the uplink frames of the product to the network (uplink) always have a size of 11 bytes.

4.1.1 Fixed bytes

The first two bytes of the frame are systematically dedicated to indicate the frame code and the status as presented below:

- Low Bat: bit at 1 if the battery voltage is less than 2.5V, otherwise 0. This information remains permanent.

4.1.2 Ask for a new ID in the White List

This 0x01 frame is sent only in INSTALLATION mode to allow the reception of a downlink "add an ID in the White List" (other downlink will be rejected).

Since the largest sigfox connectivity plan only allows a maximum of 4 downlinks per day, this frame will be sent 4 times a day maximum or the number of time specified in the register S307 (number of DL/day).

4.1.3 Ask for White List modification or configuration modification

This 0x02 frame is sent only once a day before "keep alive" frame in OPERATION mode to allow the reception of one of the following downlink:

- Suppress all IDs from the White List and switch repeater into PARK, INSTALLATION or OPERATION mode
- Delete an ID from the White List
- Add an ID in the White List
- Modify repeater configuration
- Freeze the list of devices repeated in "auto-record" mode into the White List

Other downlink will be rejected.

This 0x03 frame is consecutive to the reception of a downlink, and indicates whether the action linked to the downlink has been correctly executed or not. In the case the Downlink has not been received this confirmation frame can not be sent.

- A White List confirmation has been sent in the last "add an ID" downlink
- The White List is full (15 IDs provided)
- The last 4 uplinks "Add an ID" do not receive any downlink in return

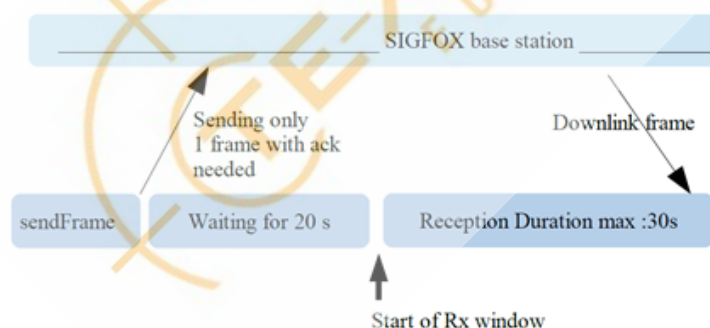
4.2. Downlink frames

SIGFOX technology allows up to 4 downlink messages to be transmitted (from the network to the product) per day depending on the subscription.

A downlink message is in fact an acknowledgment of receipt of an uplink frame with a request for acknowledgment. This means that, to receive a message on the product, an uplink frame (from the product to the network) must indicate an acknowledgment wait.

This acknowledgment downlink frame is an 8 byte message defined for the adeunis® product in the following two paragraphs.

Hence the product sends an uplink frame with the ACK field enabled, it then returns to standby for twenty seconds before opening a reception window (RX window) for a maximum of 30 seconds, in accordance with the diagram below:



4.2.1 Suppress all IDs from the White List and switch repeater into PARK, INSTALLATION or OPERATION mode

This 0x01 frame follow the uplink "Ask for White List modification" (0x02) enables to delete all the IDs from the White List and to switch the repeater into PARK, INSTALLATION or OPERATION mode.

N.B: after the add of an ID if the White List is full (15 IDs provided), the White List will be confirmed and the repeater will turn into OPERATION mode automatically.

- Byte 4: Change "Product mode" (S306) configuration

Refers to the 6.4 "Description of the registers" section to know the characteristics of each registers.

If one or several configuration are not done, a 0x10 to 0xF0 error code is sent in the uplink frame "Reporting of downlink success or failure" (0x03) otherwise it will be a success code 0x00. The repeater will reboot.

4.2.5 Freeze the list of devices repeated in "auto-record" mode into the White List

This 0x05 frame follow the uplink "Ask for White List modification" (0x02) and enables to freeze into the White List the IDs that are currently repeated in OPERATION with "auto-record" mode:

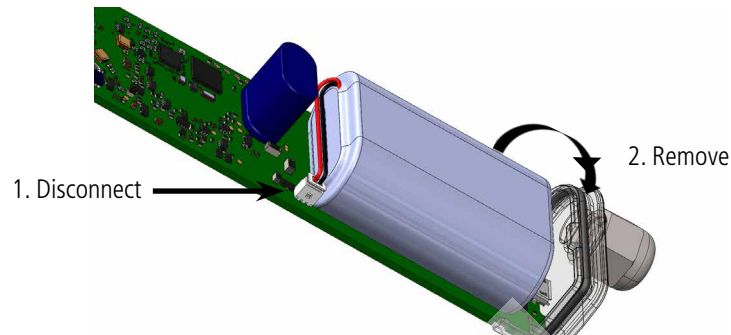

5. BATTERY REPLACEMENT AND START-UP OF THE DEVICE

5.1. Battery replacement

First, you have to open the casing using the cable gland as a lever.

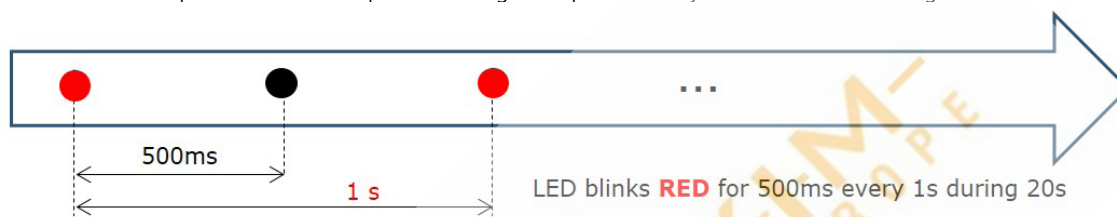
Then, disconnect the old battery pack from the electronic board as shown in picture below and remove it:



Now you can place and connect the new battery pack on the product.

Finally, close the casing following the instructions of next paragraph (6.2. Closing the casing).

Use the activation process describe in part Activating the repeater then you can see the following LED behavior.



After that if the battery has enough energy the product goes to PARK mode in the other hand the product stays in DEAD mode.

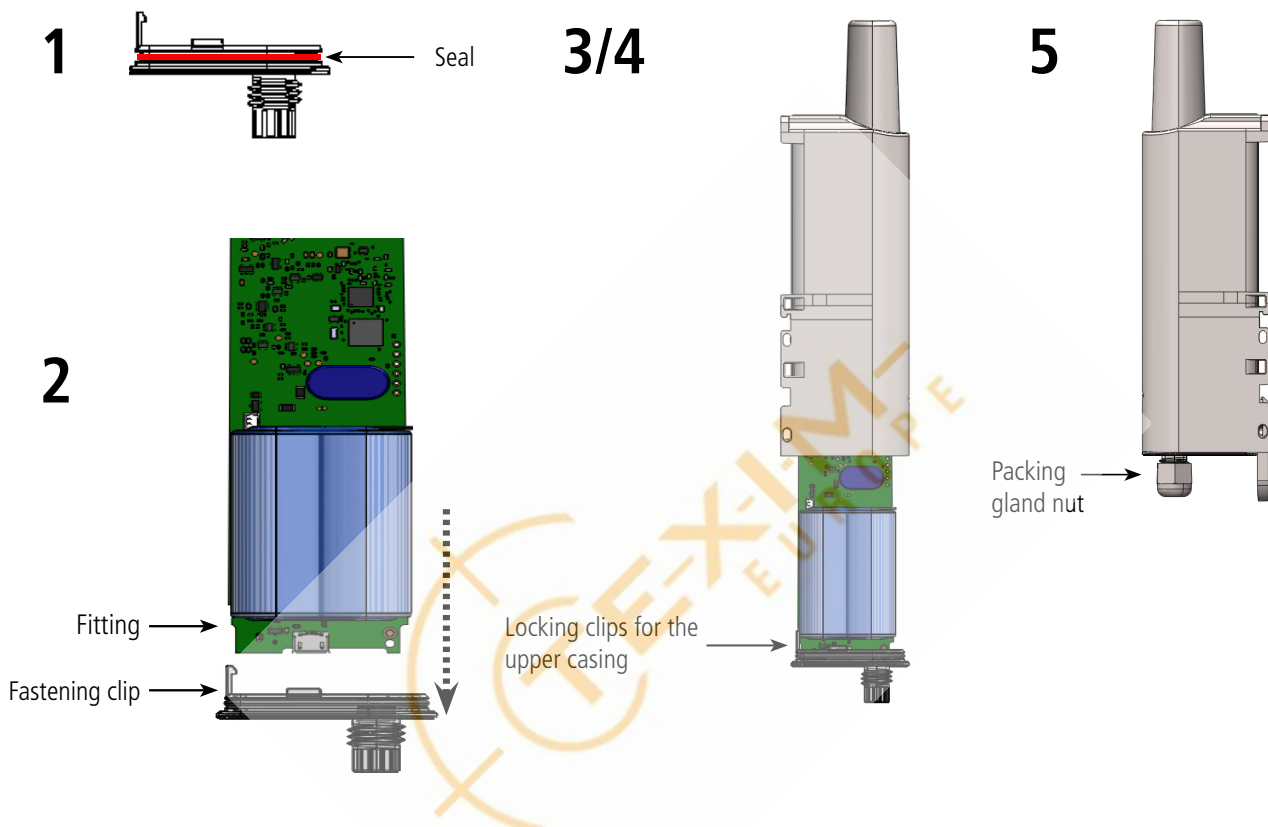
5.2. Closing the casing

Once previous stages have been carried out, you can close the casing of the Sigfox Repeater

Procedure:

1. Make sure that the seal is properly positioned on the base
2. Clip the electronic board onto the casing's base. Make sure that the fastening clip is properly locked into the board's fitting.
3. Insert the upper part of the casing. Inside this part there are guide rails for the board. Make sure that the board is properly positioned within these guides.
4. Once the board is in position, lower the upper cover and lock it onto the casing's base. Strong pressure will enable both parts to be clipped together and will enable protection level IP67 to be ensured.
5. Finish the assembly by locking the packing gland's nut in position

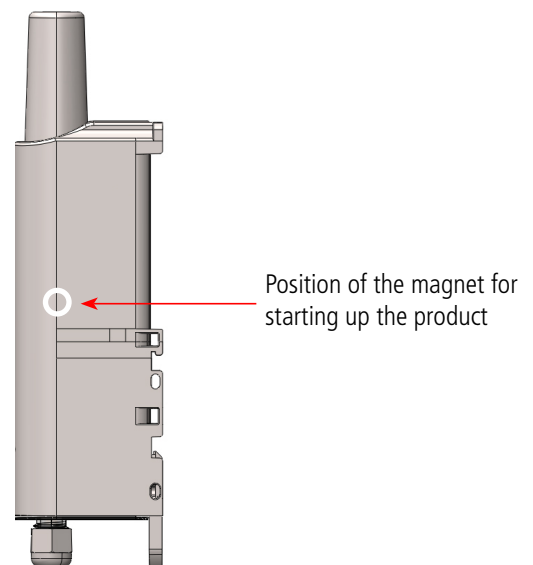


5.3. Starting up the product using a magnet

Once the product has been configured and its assembly has been finalized, the product is ready to be started up.

The start-up is carried out using a magnet which you place on the upper part of the product (cf. diagram). The magnet must be held in position for at least 6 seconds so as to confirm the start-up of the product. When the magnet is well detected, the green LED lights up for 1 second.

Once the Sigfox Repeater unit validates its start-up, it immediately transmits status frames followed by a data frame (according the defined periodicity).



6. INSTALLATION AND USE

6.1. Correct positioning of the product

There are two key rules for optimizing radio ranges.

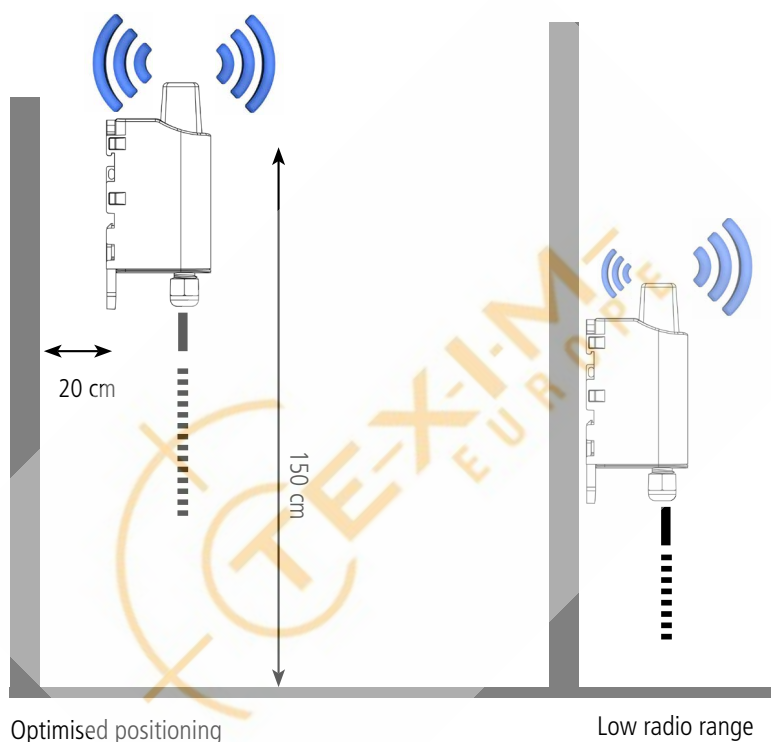
- The first one consists of positioning your product as high as possible.
- The second one consists of limiting the number of obstacles in order to avoid excessive attenuation of the radio wave.

Position: To the extent possible, install the transmitter at a minimum height of 1.50 m and do not attach it to the wall.

Obstacles: Ideally, the product must be 20 cm away from any obstacle and, if possible, near an opening (the closer the obstacle is, the more the emitted power will be absorbed). All the materials encountered by a radio wave will attenuate it. Bear in mind that metal (metal cabinets, beams, etc.) and concrete (reinforced concrete, partitions, walls, etc.) are the most critical materials for the propagation of radio waves.

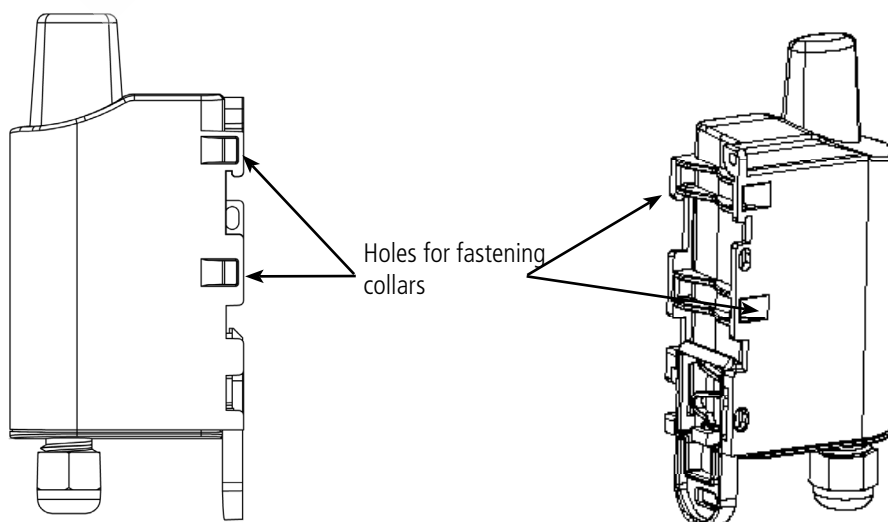
6.2. Types of fastenings

The product offers 3 fastening methods that enable numerous ways of positioning it depending on the environment where it has to be deployed.



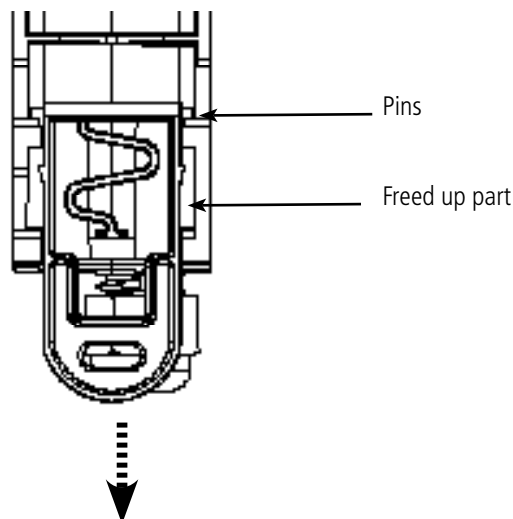
6.2.1 Tube or mast fastenings

As explained in section 4.1, the best radio performance is achieved by positioning the product as high as possible.



The fastening collar fastenings enable the product to be fastened on a mast or tube under completely safe conditions
 To optimise fastening onto a tube or mast, we recommend you remove the Rail-DIN locking/unlocking lever.

To remove it, pull the lever down until the locking pins are opposite a freed-up part and then remove the lever.



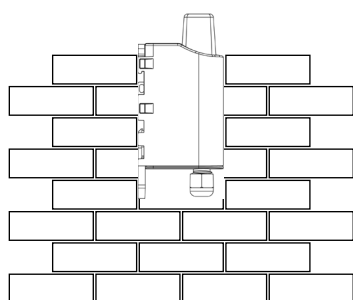
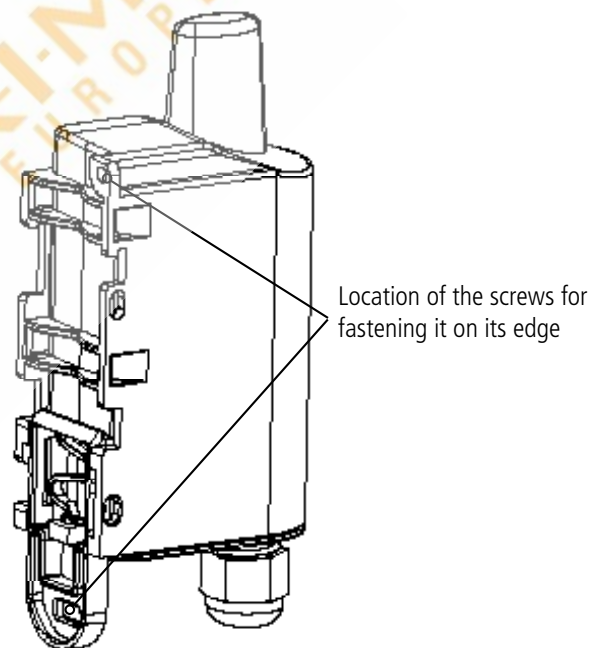
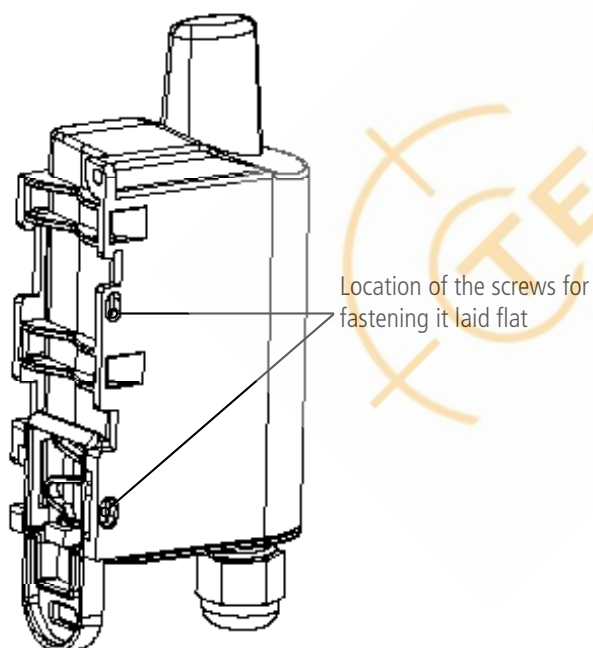

6.2.2 Fixing with screws

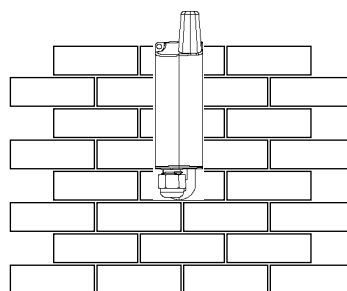
The product is delivered with 2 CBLZ 2.2 x 19 mm screws and 2 SX4 wall plugs. Use these products or equivalent products in order to fasten your product onto any flat support.

Two positions may be selected: Laid flat or on its edge.

- Placing it on its edge enables the product to be placed at a distance from its support and helps achieve better propagation of the radio waves.
- If you opt for laying it flat, make sure you remove the Rail-DIN locking/unlocking lever, as explained above



Fastening laid flat

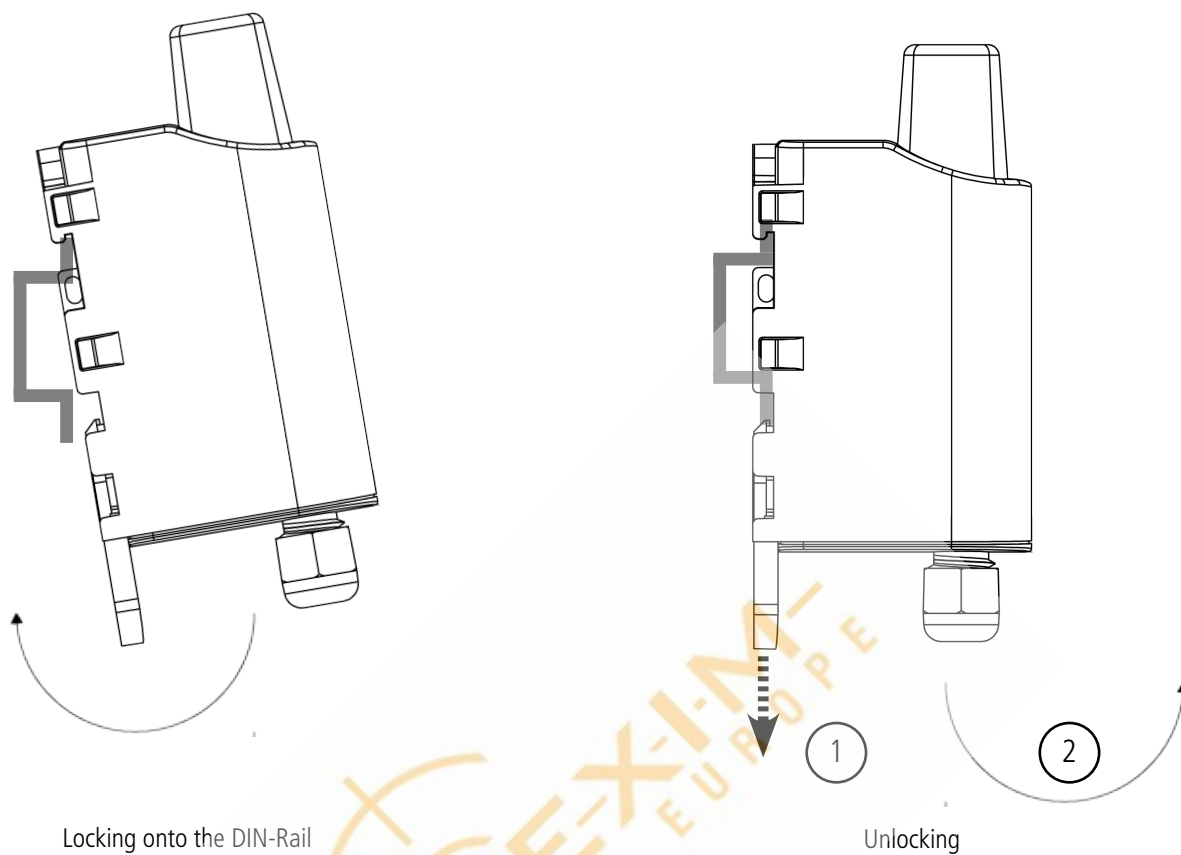


Fastening on its edge

6.2.3 DIN-Rail fixing

This system, integrated into the casing, enables the product unit to be fastened onto a standard 35 mm rail.

- To fit the casing, place the upper inserts on the rail and lower the product to clip it into position.
- To remove the product, pull the unlocking lever down and disengage the product from the rail.
